A person is deemed to have been convicted of committing a felony or misdemeanor if such person has been convicted under the laws of this state, any other state, the United States, or any territory subject to the jurisdiction of the United States of an unlawful act which, if committed within this state, would be a felony or misdemeanor. "Convicted" means a conviction by a jury or by a Court and shall also include the forfeiture of any bail, bond, or other security deposited to secure appearance by a person charged with having committed a felony or misdemeanor, the payment of a fine, a plea of nolo contendere and the imposition of a deferred or suspended sentence by the Court.

I understand that TRY Football may revoke a Coaching privileges at any time for an application which contains false information or for actions by the applicant which are not in the best interest of youth sports. Such actions shall include but not be limited to ejection from a contest, violation of TRY Football by-laws, or acts or actions in the community which cast doubt on the previously attested moral character of the applicant.
